By affixing your signature to this permit the Applicant agrees to comply with all rules, regulations and conditions required by Lower Bucks County Joint Municipal Authority (LBCJMA).

- 1 - - - - Discharging into the LBCJMA sanitary sewer system is not permitted.
- 2 - - - - Upon completion, the Applicant will be responsible for payment to LBCJMA for any and all metered water consumed.
- 3 - - - - A deposit in the amount of **\$1,500.00** must be submitted to LBCJMA for the use of the meter and backflow preventor. A \_\_\_\_\_ meter and backflow preventor must be installed **prior** to the applicant withdrawing any water.  
  
LBCJMA will supply this material to the Applicant. Should this material/equipment be damaged, stolen, etc., the deposit will be nonrefundable.
- 4 - - - - The nonrefundable Water Withdrawal Permit fee shall be paid **prior** to the withdrawal of any water.
- 5 - - - - The metered water consumption used by the Applicant will be deducted from the deposit/escrow amount submitted to LBCJMA. A check will be issued by LBCJMA to the Applicant for the remaining funds, if any. The Applicant shall pay for any and all water withdrawn over the deposit/escrow figure.

6 - - - - Please contact William Ottey, Superintendent or Vincent Capaldi, Asst. Superintendent at LBCJMA's Water Filtration Plant at 215-945-9581 to make arrangements for the equipment installation.

7 - - - - The Applicant is only permitted to withdraw water from the fire hydrant specified below. If the Applicant is found utilizing any fire hydrant other than the one specified by LBCJMA, the Applicant will be charged with theft of services.

8 - - - - This permit expires thirty (30) days from the date of issuance. This permit is required to be on the project site until said project is complete.
