LOCAL LIMITS REEVALUATION/HEADWORK ANALYSIS - PRETREATMENT PROGRAM

Per the requirements of the renewed NPDES permit for the Wastewater Treatment Plant and USEPA requirements, the Authority has submitted a list of the local limit parameters for the evaluation and sampling plan to USEPA and PADEP for their review and approval. We have started compiling the existing data and will schedule the required monitoring as soon as approval is received from the EPA.

WATER AND WASTEWATER SYSTEMS

The average daily drinking water supplied for the month of April 2018 was approximately 7.12 MGD. The monthly average effluent flow from the Wastewater Treatment Plant was approximately 10.88 MGD for the month of March 2018.
