IM Patton Associates - Mr. Jack Patton

Mr. Patton attended the Board meeting and thanked the Board for allowing his company to continue on as the Authority's insurance broker.

Mr. Patton stated that at the last meeting there was a vote to move insurance coverage from Scottsdale Insurance Co. to Philadelphia Insurance Co. Mr. Patton feels that the transition went smoothly.

GOAL

Mr. Armstrong suspended the Agenda and stated that he is on the Board of Directors of a group called GOAL. Recently, there was an awards dinner and representatives from GOAL wished to thank the Authority through Dr. Rajput who has been there giving us every kind of help he possibly can. Mr. Armstrong added that in the last three (3) years he assisted in the picking up of 400,000 lbs. of debris out of local waterways and has planted over 900 trees, 35,000 square feet of wildflower seed, recycled approximately 20 cubic yards of plastics and metal, and removed about 800 tires that were breeding grounds for mosquitoes.

Managing Director's Report

Dr. Rajput reported on the following items:

Electric Power Demand Response Program

Last year the Authority participated in a Demand Response Program which was offered by Hess Corporation for the Wastewater Treatment Plant. The duration of this program is from June 1, 2011 to May 31, 2012. During last year the Authority was required to conduct a minimum one (1) hour load curtailment test which was done by running the Wastewater Treatment Plant on the emergency power generator for approximately two (2) hours. The Authority will receive approximately \$20,000 for participating in the program.

Board Meeting Minutes January 26, 2012 Page Five

On January 17, 2012 the Authority met with representatives from Hess Corporation to discuss the renewal option for the current participation of the Wastewater Treatment Plant and explore the feasibility and economic benefit of enrolling the Water Treatment Plant and two (2) Water Pumping stations. It was determined that it is not economically beneficial to enroll any of the Wastewater Pumping Stations.

After review of all details presented it is recommended participating in the above mentioned program for a two (2) year term with the Demand Response Program offered by Hess Corporation. Dr. Rajput added that by entering into this program the Authority could see a savings of \$161,102 over a two (2) year period plus energy payment.

<u> [et-Truck</u>

During 2010-2011the Authority purchased a Jet Vac truck under the state bid (COSTAR). The Jet Vac truck was delivered in February 2011 and it was discovered that the Jet Vac system delivered did not meet the Authority's safety and performance standards. Jet-Vac felt that they exhausted every available option in trying to adjust the system to meet the Authority's required performance. Considering the available options, it was recommended selling the entire vehicle back to Jet-Vac, Inc for the purchased price of \$97,706.60.

Route 13 Construction

Mr. Armstrong advised the Board that the construction on Route 13 will begin shortly from Green Lane up to Levittown Parkway. Mr. Armstrong added that there are ten (10) businesses that are in the area of the train station that either do not have sanitary sewer service or have had problems due to pumping systems, etc. This might be an opportunity for the Authority to extend our sewer mains up in that direction. Another possibility would be if the train station is going to abandon the tunnel, which there is talk about, the possibility to have a gravity line or force main run through the tunnel in order to take the sewage over to Oxford Avenue and Main Street.
