ITEM #2: SODIUM POTASSIUM ZINC POLYPHOSPHATE/ZINC POLYPHOSPHATE

There were three (3) bidders for this chemical, however the products submitted in the bid proposals of two (2) companies have not been tested or verified for lead and copper corrosion control for the Authority's system. C-39 and CP-767D products have been tested and have demonstrated that their application and performance for the Authority water distribution system. Selection of this product was based on a corrosion control feasibility study conducted under the U.S. EPA's lead and copper rule. Because of the application of the product, the Authority was able to comply with the lead and copper concentration limits set forth in the U.S. EPA's lead and copper rule. Therefore, the Authority has standardized on Calgon Corporation's formulation C-39 and Sweetwater Technologies formulation CP-767D. It clearly states in the specifications, "No other substitute shall be acceptable." George S. Coyne Chemical Co., Inc., is the only bidder who submitted their bid for Sweet Water Technologies' Formulation of CP-767D whose product meets the contract specifications. It is recommended awarding Item No. 2: Sodium Potassium Zinc Polyphosphate/Zinc Polyphosphate to George S. Coyne Chemical Co., 3015 State Road, Croydon, PA 19021 with a bid amount of \$128.0547/CWT or \$1.2805/lb. The current unit price is \$129.84/CWT or \$1.2984/lb.

Per the requirements of the specifications, the chemicals that are being furnished and supplied are to be manufactured in the United States of America. The chemical that George S. Coyne Chemical Co. would be supplying to the Authority is not made in the USA, therefore, their bid for this chemical is not acceptable.

Based on review of the bid documents and qualifications, it is recommended awarding Item No. 4 Potassium Permanganate to Univar USA, Inc., 532 E. Emaus Street, Middletown, PA 17057 with their bid unit amount of \$347.00/CWT or \$3.47/lb. The current price is \$320.50/CWT or \$3.205/lb.

UPGRADE OF THE SCADA SYSTEM AT THE WASTEWATER TREATMENT PLANT

The Authority is continuing the upgrade of the existing computers and SCADA System at the Water Treatment Plant. This project is being completed in phases. Most of required electrical work is being done in-house by the Authority's electrician.

LOCAL LIMITS REEVALUATION/HEADWORK ANALYSIS - PRETREATMENT PROGRAM

Per the requirements of the renewed NPDES Permit for the Wastewater Treatment Plant and USEPA requirements, a list of the local limit parameters for the evaluation and sampling plan have been submitted for review.

ANNUAL WASTELOAD MANAGEMENT REPORT - CHAPTER 94 REPORT

The above report has been submitted for the reporting year of 2017.

This report present Hydraulic and Organic loading calculations and projections for the next five (5) years performance of the plant, connections to the Authority's system, plant maintenance, just to name a few. The annual daily average Wastewater flow to the Plant was 6.44 MGD for 2017, 6.07 MGD for 2016 and 6.72 MGD for 2015. This flow reduction is attributed to the Authority's Infiltration/Inflow control, certification and easement maintenance program.

A total of five (5) sewer service connections were made to the Authority's Wastewater system during 2017. The plant performance is terms of CBOD5 and Total Suspended Solid reduction efficiencies were calculated to be approximately 95% and 96.76%, respectively. The annual average DBOD5 and Total Suspended Solid concentrations in the Plant effluent were 5.44 mg/L, (permit limit – 20 mg/L) and 7.88 mg/L (permit limit – 30 mg/L) respectively.

The maintenance work completed for the Collection System during 2017 involved CCTV inspection of approximately 43,681 lineal feet of sewer pipe, jetting/cleaning of approximately 6,417 lineal feet of sewer pipe and root cutting and removal of approximately 12,822 lineal feet of sewer pipe. During the reporting year, there were 430 homes that removed trees from the Authority's Sanitary Sewer Easement areas. There were 184 homes that had broken sewer vents/cleanouts that have been repaired, and 82 Sanitary Sewer laterals were replaced.

Under the ongoing I & I Control Program in the Wastewater Collection System rehabilitation Program, approximately 51,798 lineal feet of sewer mains ranging in size from 8 inch to 15 inch were cleaned, inspected and lined during 2017.

WTP - PADEP CHAPTER 110, WATER ALLOCATION, WATER MANAGEMENT PLAN WATER WITHDRAWAL AND USE REPORTING

Under PADEP Chapter 110, water Allocation, the Water Management Plan Water Withdrawal and Use Report was submitted to PADEP. The total potable water supplied from the Water Treatment Plant during the reporting year of 2017 was approximately 2822.168 million gallons, of this, approximately 40% was calculated to be bulk water supplied. The annual daily average water was calculated to be approximately 7.862 MGD (it was 8.65 MGD for 2016). Peak water demand was recorded to be 10.83 MGD, which occurred on May 4, 2017, minimum water use of 4.787 MGD was recorded on October 21, 2017.

WWTP-190: WASTEWATER TREATMENT PLANT SCADA SYSTEM UPGRADE

As part of the ongoing installation and upgrade of the SCADA System at the Wastewater Treatment Plant, the Authority is continuing to upgrade the existing PLCs, VFDs, and connecting all equipment and process controls to the SCADA System operation room. The CLX hardware has been received to replace the existing PLC-5 for the Dissolved Air Floatation (DAF) System. Most of the required electrical work is being done in-house.

WATER AND WASTEWATER SYSTEMS

The average daily drinking water supplied for the month of March 2018 was approximately 7.17 MGD. The monthly average effluent flow from the Wastewater Treatment Plant was approximately 6.09 MGD for the month of January 2018.
