Dr. Rajput stated that bids were received and opened on October 14, 2021, for the Contract No. WWTP-430 involving furnish and supply new Kennedy Fire hydrants, Valves, and Pipe. Dr. Rajput stated that this is a unit bid price contract. As per the bid opening results, Hajoca Corporation located in Lansdale, Pennsylvania was the only bidder on this contract. Hajoca Corporation is the current contractor supplying the items listed in the attached Tabulation sheet. Their services have been very satisfactory. Dr. Rajput stated that based on our review of the bid proposals, qualifications, and technical specifications, we recommend awarding Contract No. WWTP-430 to Hajoca Corporation located in Lansdale, Pennsylvania for the unit base bid prices presented in the bid tabulation. The duration of this Contract is two (2) years.

Dr. Rajput stated that bids were received and opened on October 14, 2021, for the Contract No. WTP - 431 involving furnish and supply of Ferric Chloride (technical grade) for the Water Treatment Plant. Dr. Rajput stated that Ferric Chloride is used as a coagulant in the coagulation/flocculation process which is one of the main water treatment unit processes at the plant. The estimated yearly consumption of ferric chloride is approximately 500,000 pounds on dry weight basis.

Dr. Rajput stated that as per the bid opening results, Kemira Water Solutions, Inc. was the only bidder for this contract. Dr. Rajput stated that this is a unit bid price contract. Kemira Water Solutions, Inc. is the Authority's current supplier of Ferric Chloride and their services have been very satisfactory. Based on review of the bid proposal and qualifications, we recommend awarding Contract No. WTP-431: Furnish and Supply Ferric Chloride to the Water Treatment Plant to Kemira Water Solution, Inc., located at 3211 Clinton Parkway Center, Suite 1, Lawrence, KS with a unit price of \$39.30 per CWT dry or \$0.393 per dry pound of Ferric Chloride delivered. The duration of this contract is two (2) years. The current contract unit price is \$31.20/CWT or \$0.312 per dry pound of ferric chloride delivered, an increase of \$8.10/CWT dry or an increase of \$0.081/per dry pound.

# BULK SEWER AGREEMENT WITH BUCKS COUNTY WATER AND SEWER AUTHORITY:

Dr. Rajput stated that based on a review of the existing bulk sewer agreements with Bucks County Water & Sewer Authority (BCWSA) and advice of Mr. James A. Downey, III, Esquire, we have sent a written notice to terminate all the existing bulk sewer agreements through a letter dated October 8, 2021. We had notified BCWSA through a letter dated September 21, 2021, that LBCJMA (the Authority) has installed bulk sewer meters to begin billing BCWSA based on metered sewer flow. BCWSA raised opposition to the actual metered sewer flow-based billing referring to the existing bulk sewer agreements that the Authority had with Middletown Township.

#### TRACER STUDY AT WATER TREATMENT PLANT:

Dr. Rajput stated that we have completed the review of the draft report on the Tracer Study conducted at the Water Treatment Plant on July 27<sup>th</sup> and July 28<sup>th</sup>, prepared by GHD, (Peter Lusardi, P.E., and his staff). The report is being finalized for submission to PADEP along with PADEP required completed Request of Designation of Treatment Segments for Calculation of 1.0-Log Giardia Inactivation based on this Tracer Study data.

# WATER DISTRIBUTION SYSTEM MAINTENANCE PROGRAM: REHABILITATION / REPLACEMENT OF EXISTING WATER MAINS – PHASE 6:

Dr. Rajput stated that Replacement of approximately five (5) 6 inch valves and associated fittings on Daffodil Lane in Dogwood is complete. We will be scheduling replacement of a portion of water main at Main Street and Cheston Street in Tullytown as soon as we receive delivery of pipes.

## INSTALLATION OF PREFABRICATED METAL BUILDING/SHELTER FOR CHLORINE CYLINDER STORAGE AREA AT WATER TREATMENT PLANT:

Dr. Rajput reported that the installation of the metal building/shelter for chlorine cylinder storage is completed and currently working on installing the required door, chlorine sensor, alarm, and exhaust fan as per the requirements of USEPA.

# CONTRACT WWTP-419: REPLACEMENT OF EXISTING ODOR CONTROL WET CHEMICAL SCRUBBER WITH NEUTRALOX® PHOTOIONIZATION SYSTEM AT KENWOOD WASTEWATER PUMP STATION:

Dr. Rajput reported that they are continuing working on installing the required piping and electrical conduit/wiring. The delay in installation of the piping is mainly due to long lead times on some material including pipe. Our anticipated date of installation completion is October 28, 2021. Once all installation work is completed, we will schedule startup of Photoionization system with the supplier of the system.

# <u>CONTRACT WTP-418: REPLACEMENT OF FILTER MEDIA AT WATER TREATMENT PLANT :</u>

Dr. Rajput said they are continuing to work on compiling the required information for preparation of technical specifications and contract documents for the replacement of existing media of the existing four high-rate dual media filters for bidding process.

#### COVID-19:

We are continuing to implement and practice all required precautionary and preventive measures and maintaining the required operations of our water and wastewater systems.

#### WATER AND WASTEWATER SYSTEMS:

The average daily drinking water supplied for the month of September was approximately 5.99 MGD. This is of lowest monthly average water demand we have observed. The monthly average effluent flow from the wastewater treatment plant for the month of September was approximately 8.62 MGD.
