MANAGING DIRECTORS REPORT

CONTRACT NO. C-439: FURNISH AND SUPPLY CHEMICALS FOR LOWER BUCKS COUNTY JOINT MUNICIPAL AUTHORITY'S WATER AND WASTEWATER TREATMENT PLANTS

Dr. Rajput stated that bids were received on June 9, 2022, for Contract No C-439 involving furnishing and supplying chemicals for the Authority's Water and Wastewater Treatment Plants. Bids were invited for the supply of eight (8) chemicals that are used at both the Water and Wastewater Plants. Based on a review of the bid proposals received, the following recommendations are being made regarding the award of the individual items and individual chemicals of the contract:

ITEM No. 1: CHLORINE

Dr Rajput stated that there were three (3) bidders for Chlorine. JCI Chemical was the lowest bidder. JCI Chemical is the current supplier of chlorine to the Authority. Based on our review of the bid documents and qualifications, JCI Chemical is found to be the lowest bidder. Therefore, it is recommended awarding Item No. 1, Chlorine, to JCI Chemical located at 103 River Street, Warwick, NY 10990 with their bid amount of \$85.00/CWT or \$0.85/lb. delivered. This bidder made a note on their bid proposal that unit bid price is subject to change after September 30, 2022. Documentation and 30 days written notice will be provided. There is a provision in this contract that the supplier can request unit price increase if the supplier can demonstrate that cost increases have been industrywide and that it will create a severe economic impact on the contractor (under Force Majeure provision). Considering the current market and supply situation, not many options are available as Chlorine is one of a most critical chemicals for the Water treatment. The current contract price is \$25.00/CWT or \$0.25/lb. delivered. An increase of \$60.0/CWT or \$0.60/lb. The unit bid price of the second lowest bidder was \$116.00/CWT or \$1.163/lb.

ITEM No. 2: ZINC POLYPHOSPHATE

Dr Rajput stated that there were two (2) bidders. Shannon Chemical Corporation was the lowest bidder for Item 2. Based on review of the bid documents and qualifications, Shannon Chemical Corporation is found to be the lowest responsible bidder for item 2 of this contract. The product meets all requirement of the contract. The Authority uses this chemical to control corrosion within our water distribution pipes, which prevents lead and copper leaching from the water pipes. It is recommended awarding Item No.2, Zinc Polyphosphate to Shannon Chemical Corporation located at 311 Commerce Drive, Exton, PA 19341 in their bid amount of \$274.00/CWT or \$2.74/lb. delivered. The current contract price is \$104.44/CWT or \$1.0444/lb. delivered. An increase of \$169.56/CWT or \$1.6956/lb. delivered.

The product meets all requirements of the contract. Based on our review of the bid documents and qualifications, George S. Coyne Chemical Co. Inc. has been found to be the lowest responsible bidder. Therefore, it is recommended awarding Item No. 3, Fluorosilicic Acid to George S. Coyne Chemical Co., Inc., 3015 State Road, Croydon, PA 19021 in their bid unit amount of \$35.0125/CWT or \$0.350125/Ib. delivered. The current price of this chemical is \$29.50/CWT or \$0.2950/Ib. delivered. An increase of \$5.5125/CWT delivered.

Emmaus Street, Middletown, PA 17057 in their bid amount of \$456.80/CWT or \$4.568/lb. The current price is \$345.00/CWT or \$3.45/lb. An increase of \$111.80/CWT.

Coyne Chemical Co., Inc., 3015 State Road, Croydon, PA 19021 in their bid amount of \$234.3172/CWT or \$2.34317/lb. The current price is \$219.6461/CWT or \$2.1964/lb. An increase of \$14.6711/CWT.

ITEM No. 7: HYDRATED LIME

Dr. Rajput stated that Greer Industries (Greer Lime Company) was the only bidder for the Item 7-hydrated lime. This company is the current supplier of hydrated lime for the Authority and their services have been satisfactory. Based on our review of the bid documents and qualifications, Greer Industries is found to be the lowest responsible bidder for item 7 -hydrated lime of this contract. Therefore, it is recommend awarding Item 7 hydrated lime of Contract No. WTP-414, to Greer Industries (Greer Lime Company) located in Morgantown, West Virginia with their bid unit amount of \$12.65 /CWT or \$0.1265/lb. delivered. The current contract price is \$10.85/CWT or \$0.1085/lb. delivered. An increase of \$0.018/lb. delivered.

NOVA Consultants, Inc. have been notified to proceed with this project. They already started preliminary research and design work.
