Dr. Rajput stated that the gear drives for primary sedimentation tanks #1 and #2 are original, reaching the end of their life and are obsolete. In this regard, a proposal was obtained from Sherwood Logan & Associates, Inc., the authorized sales representative of Connexus Industries Inc., Manufacturer of SEW Eurodrive K87R57AM56DRN71M4 drive unit to replace the existing Foote Jones gear drives. These units are nearly direct replacement units and should integrate into the existing units with small modifications. Dr. Rajput stated that the quoted price for each complete gear drive unit is \$31,056.00 with a total price of \$62,112.00 for the two drives. This price is quoted under COSTARS Contract #388549 and has an approximate lead time of approximately 14 weeks. We would like to recommend to the Board for its consideration for purchasing 2 complete gear drives for primary sedimentation tanks 1 & 2 from Sherwood-Logan & Associates, Inc., located at 2140 Renard Court, Annapolis, MD 21401, under COSTARS Contract #388549 for a total contract amount of \$62,112.00 plus transportation cost.
