Affixing your signature to this permit application signifies your approval and agreement to comply with all rules, regulations and conditions required by Lower Bucks County Joint Municipal Authority (LBCJMA).

1. Discharging into LBCJMA sanitary sewer system is not permitted.
2. An escrow deposit in the amount of **\$5,000.00** shall be submitted to LBCJMA for the use of the meter. Applicant shall be responsible to provide and install a backflow preventer with the meter. Backflow preventor and hydrant meter shall be installed prior to the applicant withdrawing any water.
3. Upon completion, the Applicant shall be responsible for payment to LBCJMA for any and all metered water consumed and applicable fees. The metered water consumption used by the Applicant will be deducted from the escrow amount submitted to LBCJMA. The Applicant shall pay for any and all water withdrawn over the deposit/escrow figure. **Note: The cost for the purchase of water is based on one thousand gallons. The cost is determined by the amount of water used multiplied by \$3.23/1000 gallons. The hydrant should be opened all the way and the valve on the metered connection used to control the flow.**
4. Meter shall be returned in the condition it was issued, with no added appendages. Should the meter not be returned in its original condition, be damaged, stolen, etc., the cost to replace the equipment shall be deducted from the escrow.
5. A check will be issued by LBCJMA to the Applicant for remaining escrow, if any.
6. Arrangements for picking up the meter shall be made by contacting our meter department at 215-945-7400.
7. The Applicant shall only withdraw water from the fire hydrant specified on the permit by LBCJMA. If the Applicant is found utilizing any fire hydrant other than the one specified on the permit, the Applicant will be charged with theft of services and relinquish their escrow. If the Applicant is found withdrawing water from the designated hydrant without the required backflow preventor and meter in place, the Applicant shall be charged with theft of services and relinquish their escrow.
8. The permit shall expire thirty (30) days from the date of issuance. This permit is required to be on the project site at all times.
